This was done principally for Community use, following extensive Cass Bay consultation in a vision statement for the next 30 years. The Council, at the time, allowed the Sea Cadets of TS Steadfast to continue use the buildings, which were also used by the Cass Bay Community for activities such as a weekly playgroup and toy library, Residents Association meetings and social events and recreational activities such as walking and horse riding. After amalgamation of Banks Peninsula District Council and Christchurch City Council the gates were padlocked, for no apparent reason, with signs saying "Keep Out" and threatened people with prosecution. This meant the Community were effectively unable to access the facilities except when the Sea Cadets allowed them to use buildings for occasional social events or Reserve Management meetings. 		Having connectivity is vitally important in developing a safe, happy and resilient community to live in. Having facilities that provide a place for this to happen is essential. At present the Residents Association hold a number of community functions in the open (e.g. annual Halloween party) or a committee members homes (e.g. Committee meetings, mid-winter pot luck dinner, morning tea for elderly residents.) Local groups meet in each other's homes (craft group, book club). These types of activities have to remain limited in size due to available space. Our understanding is that Brian Downey has held a Licence to Occupy the current nursery site since 1998, and continues to fulfill the conditions of his License. 	Over the years I have worked with multiple community projects in the Lyttelton vicinity and produced approximately 7000 plants. I have developed planting stock for specific community planting plans. This requires a lead in time of two years from the collecting of seed from suitable areas to propagating and growing-on to a size suitable for the planting projects. I am currently focused on working with other community members associated with Urumau and Rāpaki planting projects. I am currently focused on working with other community members associated with Urumau and Rāpaki planting projects. My success can be attributed to good local knowledge of the various regeneration programmes in our area, and can provide forward planning and strict plant control. Meteorological Site Steadfast has also been used for my weather recording station for both temperature and rainfall for the last twenty years. These readings form the basis of the watering modelling that I use to guide community planters when to water their new plants. This system has been used on all the projects I have been involved with and ensures adequate water is provided economically to the new plantings for best survival. It is important that the station remains in the same place for consistency of the information. Guard House Since I took over the operation of the nursery, the Guard House has been an essential part of the operation. It is my office where I am able to keep planting and weather records. It is also where tools, pots and potting mix are stored. It provides a shelter where the plants are potted-up				
		The plan proposes that the guard house be renovated for community meeting use and nursery office. The building is in such a dilapidated state that, in my opinion, it is beyond any economic repair. I recommend that the community meeting space be provided within the Navy Cadet buildings as was the case before the City Council took over from the Banks Peninsula District Council. Toilet Facilities The Wardroom does have a toilet connected to a septic tank which outlets to the creek. This could be re-connected to the same sewerage line that serves the main toilet block and be suitable for small meetings.

Whilst the building is owned by the cadets the previous council paid for the block to be linked to the public sewerage system on the road. 		Security Over the years, security has been a great problem. I have had vandalism, break-ins, plants and tools stolen from the site. With the facility proposed to be open to the public, it will be necessary to have the entire nursery site, including the Guard House, properly secured. 		All ammunition bunkers had guttering, roof, and ceiling panels made from "Fibrolite" which was cement product that was reinforced with asbestos.			
		Only nine of the ten bunkers are shown on the plan. One bunker had been completely destroyed by an explosion. During the Christchurch earthquakes, five of the remaining nine bunkers were hit by rockfall causing serious damage. The shattered asbestos material in and around the bunkers may pose a health risk to the public. All the service buildings, associated with the bunkers, also contain asbestos in their roofs. There has been no investigation as to the extent of asbestos contamination. Nitrates			
		Originally, this site was for the storage of ammunition for the Royal Navy. During World War 2 the ammunition was regularly tested for compound stability in the building called the "Laboratory". To my knowledge, there was no testing on the ammunition during the period from the end of the war in 1945 until the ammunition was removed and dumped outside Lyttelton Heads in 1967 There may well have been nitrate leakage during this period. There has been no investigation into this prospect.			
		Cadet's Proposed Funding TS Godley Cadets have indicated they will be applying for \$2.5 million for an upgrade of Steadfast buildings. This is part of a universal funding application for \$10m by the Sea Cadet Association New Zealand for a "Shovel-Ready" Government funding initiative to renovate navy sites around New Zealand. To date this project seems very sketchy. I wonder what is the actual possibility of approval is? I have no knowledge as to whether SCANZ has actually applied for the fund,or whether they have been successful. So much of this proposal is predicated on the Sea Cadets getting this funding to upgrade Steadfast. The question also remains as to whether SCANZ will definitely allocate \$2.5 million to the Godley Support Committee for the stated purpose. I have no information as to the numbers of cadets in TS Godley. It would be premature for the Council to enter into an agreement with the Cadets given that it is predicated on the success of the funding application some time in the future.			
		Governance of Site I support this site as a gazetted reserve under the Reserves Act 1977 with the required Management Plan. This needs to happen sooner rather than later. The Summit Road Society is currently developing a management plan for Linda Woods Reserve which will include track networks, restoration areas, heritage and other points of interest.

In late May, we will be getting started on an ambitious project to restore Avoca Valley in Linda Woods Reserve. Avoca Valley sits below Witch Hill and is adjacent to Rāpaki Track. Over time, we intend to plant 87,000 plants and trees over 33ha of the valley. In the longer term, we also hope to restore Horotane Valley below Castle Rock. Native bush at HMNZS Steadfast will provide an important ecological corridor from Linda Woods Reserve to the harbour. We support the extension of walking tracks from Cass Bay into Whakaraupō Reserve. In time, this could link up with the network of tracks we are developing at Linda Woods Reserve. Loop tracks are particularly popular with the public and the landscape plan for HMNZS Steadfast provides an opportunity to consider the wider picture. We would be very happy to provide an update to the Banks Peninsula Community Board on our plans for Linda Woods Reserve. If hearings are held, we would like the opportunity to speak to our submission.

The Ministry decided the area was surplus to requirements and after a period the area was sold to the former Banks Peninsula District Council. It should be noted that the Ministry of defence did not feel inclined to keep the site for TS Steadfast. Once the Banks Peninsula Council took ownership they were kind enough to support the Sea Cadets to remain there, However the principal reason for the purchase was to provide recreational and heritage opportunities for the People of the Harbour Basin. ## a passion for the Port Hills

The Summit Road Society was formed in 1948 to further the vision of Harry Ell to preserve and protect the Port Hills and provide for public access. We own and manage four reserves on the Port Hills and also lead the backyard and community project 'Predator Free Port Hills'.

We have a particular interest in the draft landscape plan for HMNZS Steadfast as it is very close to one of our reserves, Linda Woods Reserve on the Heathcote side of the Port Hills. Linda Woods Reserve is a 233ha reserve between Rapaki Track and Castle Rock Reserve. The Summit Road Society is currently developing a management plan for Linda Woods Reserve which will include track networks, restoration areas, heritage and other points of interest.

With regards to HMNZS Steadfast, we support the extension of riparian planting to the head of the valley as well as native regeneration and enrichment plantings throughout the reserve. In late May, we will be getting started on an ambitious project to restore Avoca Valley in Linda Woods Reserve. Avoca Valley sits below Witch Hill and is adjacent to Rāpaki Track. Over time, we intend to plant 87,000 plants and trees over 33ha of the valley. In the longer term, we also hope to restore Horotane Valley below Castle Rock. Native bush at HMNZS Steadfast will provide an important ecological corridor from Linda Woods Reserve to the harbour.

We support the extension of walking tracks from Cass Bay into Whakaraupō Reserve. In time, this could link up with the network of tracks we are developing at Linda Woods Reserve. Loop tracks are particularly popular with the public and the landscape plan for HMNZS Steadfast provides an opportunity to consider the wider picture.



We would be very happy to provide an update to the Banks Peninsula Community Board on our plans for Linda Woods Reserve. If hearings are held, we would like the opportunity to speak to our submission.

## Hi Antony,

I received the 'Draft Steadfast Plans' from Jenny Healy last night. I was unable to attend the Reserves meeting when you presented this.

By way of 'background' I am a neighbour to Steadfast, and have lived in the bay for 10 years. I was part of a group who developed a walking track to the summit 4-5 years ago, before it was shut down.

I joined the Cass bay 'reserves' committee so I could be the voice of the more 'active' members of the community (the runners, hikers and bikers) who felt they were being shut out from the hills, and weren't getting access to the summit.

I have looked at your draft plans and have some concerns? I have emailed, Jenny who highlighted that she will be in communication with you today. However, I just wanted to ensure that the voice, of those in the community who like to hike, run and bike tracks is heard.

We were all at that meeting when it was highlighted that in the community report from 20 years ago, the community ask for bike/walking tracks, and the demand for them has not changed as we've asked for them again, and again in subsequent Steadfast planning meetings. My concern is that there is no mention of bike tracks in this development plan at all.

I believe you've done a great job, especially with

- tracks within Steadfast and identifying the demand to access the summit. This however, needs to be identified that the demand is for duel bike/walking access
- identifying that a short grassed boundary needs that need to be created between Steadfast and residents. Especially given the recent fires on our property in Cass Bay
- identifying that pockets of plantings need to happen (not just let gorse go).

The key areas that I would like to see revisited

- Access has always been an issue, **Second Second S**
- I would like to see a loop flow track (Green Line See map below) designed for intermediate Mountain bikers but that can be used by runners and walkers. This track could also provide access to the small native planting areas. Look at what has been achieved by Canterbury Single Track Club out at Halswell Quarry and how popular that is. The kids of Cass Bay/Lyttelton have nowhere local to safely ride their bikes. I am not saying that we need the number of tracks that Halswell has, one loop track and access to the summit would be more than adequate.
- I think also a large 'fire break' track (See the orange line See map below), 4wd in size that is also good for either biking/walking needs to be put around the perimeter of Steadfast neighbouring the reserve. This would provide small security for Steadfast, as well as provide access for firemen when fires occur (which they will).
- Don't underestimate Parking requirements once we get access to the summit for Walkers, Bikers, Runners this will become a very popular asset. Just look at Rapaki, Bridle Path etc.

As highlighted, I sit on the Cass Bay Reserves Committee, I did this to be the voice of those enthusiast members of the community who like to use the local tracks for hiking, running and biking. My role within Reserves Committee is managing the track 'working bees' and managing the pest control for Cass bay & Steadfast (currently 5 traps).
