without impacting on the rest of the park or its users. There are also basic facilities and a drinking fountain immediately nearby. The playground can then also be used by younger siblings of skate park users. The lack of nearby food options might also actually help in deterring youth "hanging out" all day.
Halswell Domain also provides most of the above options, but I do feel that there is plenty already happening in this park year round and another recreational item of this nature is highly likely to draw in a large number of extra users. I would support the option near the Model Railway and strongly oppose the location near the League grounds due to it's obscurity from the road.
Scott Park is NOT a great choice simply by the lack of toilets and water drinking facilities. No child is going to hold on to a call of nature for the length of the drive to Halswell Domian, let alone those who have made their way to Scott Park by skateboard and would need to skate to the Domain. The nearby garden along the edge of the park would simply turn into a toilet for users of all ages.
Finally, Knights Stream Sports Park looks ON PAPER as though it should be a good option. But I am loathe to see money invested into something that is based only the "anticipation" that many more young families will move into the area. It is also VERY lopsided and non-central in its location for the greater Halswell area, and is very likely to only end up catering to the immediate neighbourhood.
