Thank you for your email, received on 7 July 2017. You requested the following information, under the Local Government Official Information and Meetings Act 1987 (LGOIMA):

- *How many full-time male employees sit within each remuneration band (less than \$60,000/ \$60,000 - \$79,999/ \$80,000 - \$99,999/ \$100,000 - \$119,999/ \$120,000 - \$139,999/ \$140,000 - \$159,999/ \$160,000 - \$179,999/ \$180,000 - \$219,999/ \$220,000 - \$299,999/ \$300,000 - \$399,999)*
- *Please note – this excludes elected city councillors."*

Release of information

Based on current data, we have 852 full-time female employees working at the Council and 908 full-time male employees. In terms of leadership positions 46% of our leadership roles are held by women, and this compares favourably with women holding 48% of our full-time positions.

The requested salary breakdown is in the table below. This excludes the Chief Executive's salary, as it is outside the salary bands requested, but this information is on page 202 of the 2015/16 Annual Report, at:
