



## **PUBLIC NOTICE OF AVAILABILITY OF LATE SUBMISSIONS AND RIGHT TO MAKE A FURTHER SUBMISSION**

1. On 9 February 2016 the Christchurch City Council publicly notified a proposal for residential medium density zoning in parts of Hornby, Linwood and Papanui. The period for making submissions on this proposal closed on 22 March 2016. Under the provisions of Clause 5(1)(b) of Schedule 3 Canterbury Earthquake (Christchurch Replacement District Plan) Order 2014, the chairperson of the Independent Hearings Panel has accepted late submissions from:

- Simon Fowke (RMD128)
- Mary Scales (RMD129)

All submissions oppose the proposal for Papanui.

- Any person that has an interest in the proposal greater than the interest that the general public has.
- Christchurch City Council.

4. Any further submission must be limited to a matter in support of, or in opposition to, the submission made by Maureen and Colin McGavin, Simon Fowke and Mary Scales and must state whether or not you wish to be heard.

5. Any further submission must be served on the Christchurch City Council. A copy must also be served by the further submitter on Maureen and Colin McGavin, Simon Fowke or Mary Scales within five working days after the further submission is delivered to the Christchurch City Council.
