

We offer assistance for our customers to get a taxi from our premises. For evening functions IAC staff remain on site to ensure all customers leave the event safely. Promotion of these transport options is advertised within the alcohol serving areas for all staff and customers to view.

- c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?
  - Free water available at all times. Menus on display at all times and staff actively promote customers to consume water, low alcohol beverages and food. All evening functions and special events are catered and non alcoholic and low alcoholic beverages are available.
- d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?
  - IAC staff always ask to see acceptable forms of identification. Customers who are visibly intoxicated will not be served alcohol, instead they will be encouraged to drink water, eat food and may be asked to leave. IAC staff encourage them to take advantage of the safe transport options
- e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)
  - Free water is actively presented and available at all times. There is a free water station available for customers to access at all times in the cafe and jugs of water are available at the evening functions and special events. Appropriate signage is displayed at points of service.
- f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?
  - IAC will have a Duty Manager on duty at all times and all staff will be trained on the Host Responsibility Policy, this will be presented in an appropriate area for all to see at all times. The DM will hold a current license and it will be their responsibility so ensure we comply with the law.
- g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?
  - Current noise levels for the attraction are minimal. Noise may occur from entertainment within the attraction at evening functions and events. Noise levels will be monitored by IAC staff. IAC is not located close to other buildings/ businesses/ households etc. to not disturb others.
- h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?
  - Current levels of nuisance and vandalism are nil and granting of a license will not change this. Any customers that acts with this behavior will be asked to leave the premise and encouraged to take advantage of safe transport options.
- i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)
  - Other licensed premises in the area are Lone Star (Spitfire Square), and both the Sudima Hotel and the Novotel Hotel as well as some licensed areas within the Airport Terminal. No, granting of this license will not increase alcohol related problems in the area due to the nature of the area.
- j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?
  - The surrounding areas are owned by CHCH International Airport. Across the road is airport parking. On one side is the IAC which includes Antarctica New Zealand, Antarctic Heritage Trust, etc. Other side is Sudima Hotel, nearby is Jucy Snooze and Spitfire Square, retail and food.
