Staff will be trained to inquire and intervene when appropriate to ensure patrons have safe transport options when leaving the proposed premises. They will be trained to organize taxi, uber etc and ensure patrons leave the premises in them.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

All bar and wait staff will be trained in server intervention, slowing down service, offering food from the extensive snack and dinner menus, low and no alcohol options, communication between all service team members when monitoring for premise and patron compliance

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

All staff are trained in the SCAB intoxication model and in checking ID minors will not be permitted after 10:00pm and only before 10:00pm when accompanied by there legal guardians for purpose for dining. Any person showing signs of intoxication will not be permitted on the premises.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)

Water will be supplied to tables by waitstaff during dinner service with an additional water station located on the bar with glasses at all times.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All bar service staff and some wait staff will have completed a LCQ. Servewise Online refresher training will be conducted regularly, along with training of all staff in the premises Host Responsibility Policy,

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The proposed premises are in an industrial area with no residential properties nearby. There are no outdoor areas for patrons to congregate. The principal entrance is located down a driveway from Lincoln Road. It is not expected possible future noise levels will increase by more.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Currently being an industrial area with light commercial and industrial businesses there is no obvious issues with nuisance and vandalism. Possible future levels will be mitigated through good surveillance of the outside areas by staff, and use of CCTV surveillance viewed at the bar.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are no licensed areas in the vicinity of the premise. The premise is located down a driveway and has no road frontage. It is predominantly targeting Korean patrons with the menu offerings and signage will be in Korean language.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The land near the premise is used for light industrial and commercial businesses. Including car repairs, warehousing and office buildings. There are no residential dwellings in the vicinity of the premise. The railway line is nearby also a disused lot which is used as a parking area.
