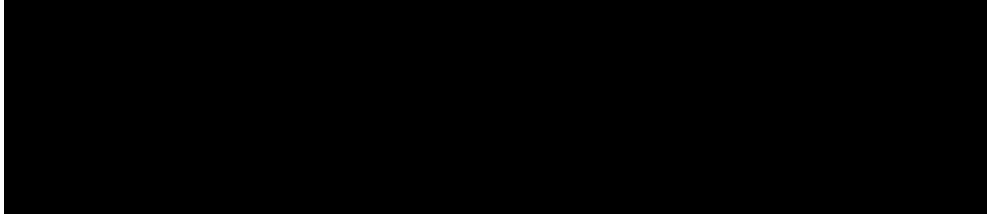

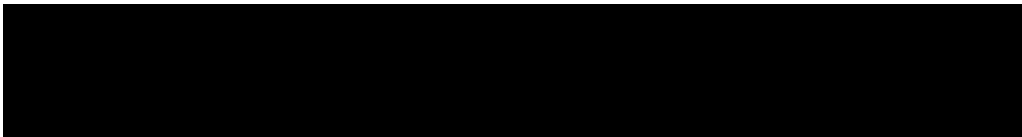

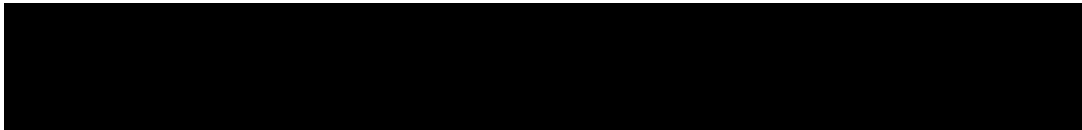

- Non-alcoholic refreshments: A range of 0% alcohol beers. A range of fruit juices, soft drinks, tea & coffee. Free water available at all times.
- Low-alcoholic beverages (Between 1.1% and 2.5%ALC): Low alcohol beer & wine is available. Free iced water at all times is available.

We promote public transport & have bus timetables available & a bus stop is located opposite the hotel. We assist when required with calling taxis & encourage customers to have a designated sober driver. We provide a free carless coach for patrons at certain times.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Free food is provided on our busiest nights & we ensure these services are advertised to our customers. All our staff are aware and adhere to our Host Responsibility Policy. They receive on-going training in this and are responsible.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

We display the appropriate signage. We observe & talk to our customers. Staff are responsible for viewing ID for proof of age. Intoxicated persons will not be served alcohol & will not be able to remain on the premises. All our bar staff are encouraged to get their Lic. Security is employed when required.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Iced water is attractively presented & is available free of charge, at all times via a water station (see attached photo). Free iced water is also available at all Bars & Water Bottles for tables.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All new staff receive training on our host responsibility Policy. This training and their obligations are constantly emphasized to all staff and we provide support to ensure they can do their job responsibly.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

We have no recent history of any noise complaints. Our closest residents live about 200m away. We have 53 model units on site and keep noise levels low to ensure guests are happy.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Nothing at all has happened for many years in regard to these matters. We do keep an eye on any potential problems. We have CCTV operating at all times which covers the entire premises inside & out.

i. What other licensed premises are in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Riccarton Park Racecourse is located directly opposite the Hotel. I do not believe granting this licence will increase problems in the area. On Race Days we actively control patrons from the races with Security Services.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

We are located in a well established area. Riccarton Racecourse is directly opposite the Hotel. Commercial Premises located to one side and residential housing some distance away. Granting this licence will have no impact on neighboring land use.

Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
