We have signs up for Transport Options and staff are familiar with local transport options so can advise call and help customers as well.

Educating staff on risk signs etc with intoxicated people and ensuring anyone who looks under the age of 25 is asked for ID - as well as security being educated on the same tasks.

We have a plumbed water station advertised at the end of the bar but also offer free water over the bar at anytime during our open hours/anytime.

We have in house training, on line training with NZ Hospitality which will be continued to be updated and ongoing. We have monthly catchups and weekly catchups on the happenings in the bar.

We only have live/karaoke once a month, but keep doors closed to keep the noise down. We monitor speaker volumes during these times.

1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

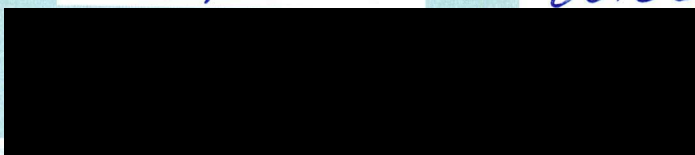
