A designated taxi rank directly in front of our public entrance. A range of signage throughout the venue advising customers of transport options. Security is available at all opening times at the entrance to assist with arranging alternative transport/ride-sharing. Taxi chits available for use.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

A range of signage throughout the venue promoting non and low-alcohol products and responsible consumption. Promotions of non and low alcohol products. Regular training to all staff and dedicated staff to monitor customers. A RSA Policy and our Playsafe/Drinksafe Brand.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Being an R20 venue with Security at our entrance at all times, anyone appearing 25 years or younger is asked for ID; other staff check ID as required. Ongoing training, clear/open lines of communication with staff and customers for early intervention offering food, non-alcoholic drinks.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Each eatery/bar has at least 1 water station for customers to 'help themselves'; we have taps plumbed in.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Security at the entrance at all opening times. Dedicated Duty Manager positions tasked with monitoring of customers and intervening. Internal Host Responsibility training for all staff, including refresher training. A Host Responsibility Manager and Team and full Host Responsibility Policy.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

There are minimal noise levels from within the building. The potential for noise from external sources is monitored via Security conducting regular external patrols and Surveillance coverage of footpaths and street areas around our building.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

There are minimal levels of nuisance and vandalism. Security being always present at our entrance and regularly patrolling external areas of our building including carparks, as well as CCTV coverage of surrounds. We also record any security or behaviour incidents in our internal database.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The Bog, Calendar Girls, The Jolly Poacher, Koji, Gunpowder, Eleven, Arcadia, Three Cows, Kum Pun Thai, Thirsty Liquor, Black & White Coffee. Due to our Host Responsibility Policy and resources to strictly/effectively enforce (noting the steps above), we manage alcohol very well.

Predominately commercial use, hence we do not expect granting the licence to have any impact.

3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

### 14. Important to note – Renewal with Variation Lodgement and Invoicing

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
