We offer the ability for patrons to book an Uber on their tab. We provide bus timetables on request. We provide more than the required minimum bicycle parks.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Water is available at every table at all times and 3 water stations are available in the trade area. Accessibly-priced menu items are available. Floating Duty Manager role ensures no patron who appears intoxicated is served a further alcoholic drink.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

All staff are required to observe the Challenge 25 practice. All staff are regularly trained to use the SCAB intoxication assessment tool. All staff are regularly trained on how request ID and raise concerns regarding the sale of alcohol to any patron.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)

There is a plumbed filtered water station, along with glasses and bottles, available on the trade area floor for patrons to help themselves. Chilled water is also be available from the bar. As previously stated, water is provided on every table as standard.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

As above, all staff members are regularly trained on the responsible sale of alcohol with regard to both intoxicated persons and minors. A Duty Manager is on site at all times during our licensed period.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

We monitor outside noise levels generated by patrons. Our noise levels are significantly lower than that of the live music venues in the area, as we do not propose regular live music events. A sign is posted in the window, requesting patrons consider our neighbours on their departure.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Current levels of nuisance and vandalism in the area are very low, in our experience. Anyone (patrons or staff) observed engaging in nuisance or vandalism before or after visiting our premises will be reported to the local authorities.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Tap Room, Dark Room, Space Academy, Lotus Heart, Arcadia. We are unaware of any alcohol related problems in the area and the level of activity generated by the granting of our license will contribute minimally to any that do exist, given the higher price-point of products.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

All neighbouring land is mixed use; a mix of residential, retail, hospitality, personal and professional services. The granting of a license will in no way impact on changing neighbouring land use.
