Minors are not allowed on premise without parent/guardian supervision. Authorized ID is required for all individuals appearing under 25. Persons who are unable to supply ID, appear intoxicated, or otherwise should not be served alcohol will be refused service.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)

Drinking water is freely available at a self service water station and by request.

- f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?
   A Duty Manager is stationed at all times during operating hours. All staff are trained in the requirements of the law. Hospitality NZ signage is posted in the break area.
- g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?
   Noise is at conversational levels and is not audible from outside the unit. Ambiance music is kept at a conversational level.
- What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?
   We have no known reports of vandalism or nuisance related to our presence. Security cameras are operational inside the shop.

- 1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.
