All staff are regularly trained about who a prohibited person is and know the S.C.A.B signs and what to look out for. Anyone who looks under 25 is asked for ID.

Drinking water is freely available at our clearly signed Free water station as well as extra bottles in fridge.

Staff have been trained appropriately and an On-Licence Toolkit is on site for any extra info required for staff as well as a experienced duty manager on site.

We have no issues with noise levels being located in a Health centre and being in a largely residential area.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We are a daytime cafe where people only consume 1-2 glasses of alcohol with a substantial meal so this behavior would not be possible.

There is a Bar across the street "The Longnight" and "Quebed coffee lounge" both licensed and this will not cause an increase

## 12. Important to note – Public notification of application

  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

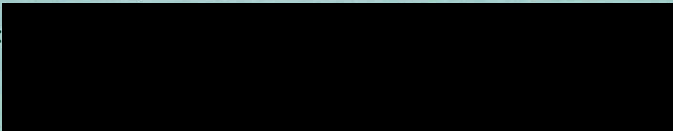

### 14. Important to note – Renewal with Variation Lodgement and Invoicing

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
