WE HAVE SIGNAGE OF FOOD AVAILABLE AT ALL TIMES AND DISPLAY OF SIGNAGE ALCOHOL WILL NOT BE SERVED TO MINORS.WE GOT FREE WATER AVAILABLE AT BAR ALL THE TIME AND GOT SIGNAGE PROMOTING TO LESS ALCHOL INTAKE.

WE HAVE TRAININED OUR STAFF ACCORDING TO HOSPITALITY NEW ZEALAND GUIDELINE AND WE DISPLAY ALL THE SIGNAGE SHOWING ALCOHOL WILL NOT BE SERVED TO MINORS AND INTOXICATED PERSON.

WE HAVE FREE WATER AVAILABLE AT ALL TIME AT BAR COUNTER AND ON REQUEST OR WITH MEALS

WE TRAIN OUR NEW OR OLD STAFF REGULARLY EVERY SIX MONTHLY OR WHEN THEY JOIN OUR TEAM AND WE DO OUR OWN IN HOUSE QUIZ TRAINING FOR KEEPING STAFF UP TO DATE WITH THE CHANGING OF HOSPO RULES AND UPDATES.

WE FOLLOW HOSPITALITY NZ NOISE MANAGEMENT PLAN AND ALWAYS TRY TO BE A GOOD HOST AND KEEP OUR WATCH THAT WE DON'T DISCOMFORT ANY OF OUR NEIGHBOURS AND WE HAVE NOT RECIVED ANY COMPLAINTS SINCE WE HAVE BEEN OPEN.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

WE HAVE 24/7 SECURITY CAMERS OPERATING IN AND OUT SURROUNDINGS AND WE DO SWEEP THE AREA OF PREMISES ALL THE TIME AND ON BUSY NIGHT WE HAVE A SECURITY GAURD TO KEEP OUR PATRONS SAFE.

WE HAVE BIG DADDY LIQUOR STORE, COUNTDOWN, NUGGETS BAR & BRICKTON'S BAR NEAR BY BUT THEY ALL SITUATED MORE THAN 1.5KM TO 2KM AWAY AND RENEWING LICENCE WOULD NOT MAKE ANY INCREASE IN ALCOHOL RELATED PROBLEMS.

Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
