Signs are displayed prohibiting the sale of alcohol to minors or any person who is intoxicated. Evidence of age document required from anyone appearing underage.

A water station is located at the front of the bar and is visable to all. Water and glasses provided and refreshed as required by staff.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Any incident reported to the manager. Staff to receive alcohol compliance and responsible server training provided either in house by a senior manager or external provider. Training content based on Servewise/ On licence toolkit or similar.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

No current noise issues. Manager monitors noise levels.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

No current issues. The premise is maintained to a high standard. Security employed for large functions and oversee patrons leaving and monitor behaviour in the locality.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The Pedal Pusher, Woodstock Craft Beer & Eatery, Miller Bar. The applicant premise has had a minimal impact if any on the surrounding locality.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The premise is located in the commercial centre surrounded by a mixture of businesses. The granting of this licence will cause no change to neighbouring land use.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

- 1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.
