All bar staffs are trained to identify minor with their valid ID before serving. They are also trained to recognised sign of intoxication and equipped with skills to managed the situation. Water and food will be offered to customers to slow down the consumption of alcohol.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Free water is available at the bar in water cooler and sealed bottled. Waters are monitored to prevent spiking issues.

Staff receives training from the Manager and the manager has been trained and posseses a Licensed Controller Qualifications

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The noise level is low most of the time, noise is monitored with a decibel meter and controlled to an appropriate level when there are performances.

There are no recorded vandalism on the premise. Security camera are installed on the premise and this deters vandalism around the premise.

The surrounding area is primarily commercial zone. As our primary goal is to serve as a performance space, it will not cause a major impact around the neighbourhood.

All premises around the land are commercial zoned. There will be no changes to the land use.

## 12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on [ccc.govt.nz/alcohol](http://ccc.govt.nz/alcohol). Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
