Signage indicating that intoxicated persons will not be served, and will be asked politely to exit the premises. Appropriate training for all staff, ie minimum LCQ. Providing and encouraging consumption of water and food where appropriate.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Signage stating the ACT is enforced at all times. Signage stating that Alcohol will not be served to prohibited persons, specifically persons who are underage (minors), and persons who are deemed to be intoxicated. Where appropriate, staff to undergo training with LCQ.

Water will be provided by way of chilled water bottles stored in the fridge.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Current staff have training with LCQ, and/or extensive experience in service of Alcohol. All new staff will be trained or already have qualifications for LCQ minimum, or have current Duty Manager Certificate.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The Riverside market is located in a non-residential area, and noise levels are appropriate for the location. Future noise levels will not increase as a result of our presence there. Our stall is a small part of a greater Market area and opening hours in line with those of the market.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Current levels of nuisance and vandalism are minimal and/or appropriate for Riverside market. Our stall is focused on OFF premise sales, most of our alcohol sales will be purchased and taken away for consumption, and therefore not be contributing to an increase in nuisance/vandalism.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are a number of restaurants and bars inside and around Riverside Markets. The granting of this licence will not contribute to an increase in alcohol related problems as the supply is primarily for tasting samples only (<30mls), and bottles sales for takeaway.

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
