We are in an industrial area where noise levels have not been an issue. We have had one private function that had loud music outside of the designated time and we have changed our private functions policy to include specific music times that end at 11pm.

None that we are aware of.

None. Wigram Brewing is in an industrial area approximately 2 kilometers away from the closest bar in Wigram "The Good Home". Hangar57's opening hours are between 12 and 7pm, and 8pm in summer.
