Taxi's are able to queue across the road from entrance, we are also happy to assist someone getting home along with calling a cab. We have wifi available on request making its easy for patrons to access transport apps such as Uber. We have a host responsibility policy (attached).

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

We and our staff believe that alcohol should be served responsibly or not at all. In aid of this we serve law/non alcoholic beverages, food, monitor patrons extensively for signs of intoxication and ensure staff are well trained in dealing with intoxication issues. Please refer to our host responsibility policy for further information.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

The applicant has an alcohol management plan that deals with its obligations in respect of the requirements of the act in relation to the sale of alcohol to prohibited persons. It has specific plans for how to deal with intoxication, minors and other issues that may arise in the course of business. Please refer to the AMP.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)

Free drinking water is available at each bar at anytime. A jug of water and glasses are put on each bar at the start of each night and always monitored by the staff. We also have water bottles available for free stocked in our fridges.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All staff will have 6 monthly training in relation to the following areas: Intoxication, minors, intervention, host responsibility.Operational procedures and the licence conditions of the premises. Training Policy and records will be maintained and the duty manager is responsible for compliance (as well as other stuff) Please refer to AMP

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The premises has been operating as a adult entertainment venue for nearly 9 years. We do not expect any noise levels to rise in the future and will continue to ensure that the noise does not exceed a reasonable level. Please refer to the NOMP.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

At present there are low levels to zero of nuisance and vandalism. The applicant intends to maintain this and mitigate any nuisance and vandalism through the use of security staff managing adjacent boundaries, and requiring staff to tidy rubbish and graffiti outside the premises. Staff will also monitor impact on neighbours.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Eleven, The Bog, Jolly Poacher, CHCH Casino, 3 Cows, Indian, Japanese, Thai restaurants. The area does not suffer largely from alcohol related problems.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The area surrounding the premises are already established and Calendar Girls has been operating for nearly 9 years without any problems. The area is made up of offices and cafes through the day and night time is largely hospitality venues.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
