No special promotions, such as 2-for-1 deals, will be offered. We prioritize host responsibility by focusing on providing a high-quality dining experience without encouraging excessive consumption through discounts. Our goal is to maintain a safe and enjoyable environment for all patrons.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

We will ensure compliance with the Alcohol Act by training our staff to check IDs, refuse service to intoxicated persons, enforce a strict "No ID, No Service" policy, and have a Duty Manager on-site at all times.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)

Water is provided to every guest upon seating, with table service ensuring their water is consistently topped up throughout their visit.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?
 All staff have completed ServeWise training and are educated on host responsibility. We also encourage them to pursue their LCQ certification.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them? Levels are low as we are solely focused on dining.

- h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?
   The Crossing complex is fully locked at night, is under constant surveillance and has security. Very low future levels of nuisance.

Austin Club (200 m away) It won't contribute to an increase in alcohol related problems, Elements is only open in the daytime.

  - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
