## 9 Host Responsibility

a.

Food will always be available. Its availability will be advertised by signage and its consumption will be encouraged by staff, so as to slow the onset of intoxication.

A range of sodas, non-alcoholic cocktails, tea and coffee will always be available. Tap water will be provided free of charge, either from the bar or from designated water stations.

Low-alcohol beer will always be available. Spirits will be served as singles where requested.

See All Day Menu and Drinks Lists, attached.

b.

A telephone will always be available for patrons to call a taxi. Taxis will be promoted as a safe transport option. A courtesy van is available at all times and is advertised extensively throughout the premises.

c.

We will provide free postmix drinks to designated drivers. Staff will be proactive in recommending food and non-alcoholic drinks. We will comply with regulations regarding discounting of drinks and the advertising thereof.

d.

All staff will be trained to ask for identification, and will refuse service and communicate with management and security if in doubt as to age or intoxication. All staff undergo regular training on the Sale of Alcohol Act and their obligations.

e.

Tap water will be provided free of charge, either from the bar or from designated water stations, accessible without staff interaction.

f.

Staff will undergo training as part of the induction process before commencing work in regards to their responsibilities under the Sale and Supply of Alcohol Act 2012. This will be supplemented by regular refresher training sessions, as well as on-the-job training. There will be multiple qualified managers working on higher-risk shifts, such as Friday or Saturday evenings, so as to provide support for the Duty Manager regarding compliance issues. The Duty Manager will always be a 'rostered extra', and will be free to roam the premises and ensure compliance, rather than being stuck behind the bar.

g.

Noise levels will be monitored by the Duty Manager. Outdoor speakers are angled so as to minimise sound carrying.

h.

Our management monitor the premises and the surrounding areas for vandalism, nuisance etc. and aim to prevent disorderly behavior before it occurs/escalates. CCTV will monitor the exteriors of the premises to act as a deterrent.

i.

There are no licensed premises in the immediate vicinity.

We take our obligations under the Sale and Supply of Alcohol Act 2012 very seriously and, as such, are extremely diligent and forthright in dealing with any compliance issues, so as to ensure the sale, supply, and consumption of alcohol is undertaken safely and responsibly, and the harm caused by the excessive or inappropriate consumption of alcohol is minimized. As such, there will be no increase in alcohol related problems in the area.

j.

The premises are set back from the road within a large carpark. The area surrounding the carpark is residential. The granting of a licence will not impact on neighbouring land use.
