A desktop search shows the nearest other licensed premises are The Christchurch Club to the West on Worcester Street, and the Christchurch Bowling Club to the East on Worcester Street. Once completed, Te Kaha/One NZ Stadium will be apprx 170m to the South. The hotel has been licensed for some time and there is no reason to believe that the granting of this licence will contribute to an increase.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The surrounding land is mainly residential, with a couple of commercial accommodation providers nearby. Latimer Square is across the road, and Te Kaha/One NZ Stadium (once completed) will be located approx 170m away to the South. As the hotel has been licensed for some time, there is no reason to believe that granting this licence will impact on neighbouring land use.

- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
