We have the age chart displaying in counter which helps staff to figure out the appropriate age to drink alcohol as well as our manager train staff when they join. We have responsible host policy which staff reads through when they first joins. We are also enrolling our staff to short courses.

Current noise control level are low and we do not have any noise Complaints. We usually keep the music in low tone being a family restaurant and usually stop playing the music after 10.00pm

We encourage our staff to keep an eye on guests so they do not get intoxicated. This helps us to control the nuisance and any vandalism.

We are located right on the Lyttelton port. There are several other restaurant and Bar on London St in Lyttelton. We do not thinl granting this license will increase in alcohol related problems in the area.



This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.
