

Correct signage stating no service to those under age or without ID, a Duty Manager on at all times to manage and supervise any bar staff, a comphrensive staff training

There is a water station within easy access to customers at the bar at all times.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

There is training for all staff working at Tiger Baby to ensure compliance. All staff are supervised by a Duty Manager at all times, and often as we are a small venue there is only one staff on most nights. All current staff working at Tiger Baby have their Managers Certificate.

- g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?
   Very low we have a bluetooth speaker only
- h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them? Very low - we are a small bar with no plans for live or loud music events.
- i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Jaba Grill and Bar and Amano Restaurants in the same courtyard. This won't add to any increase in problems as they are high end restaurants and often have closed by 10pm while Tiger Baby is a smaller operation with an emphasis on cozy and small groups.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Currently it is a commerical zone with businesses and some apartments across the road. There are many other hospitality venues around us and the new stadium build less than 50m away. Tiger Baby won't impact any current use.

  - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
