Host Responsibility

Question 9:

A: We are a Supermarket; we sell both No Alcoholic and Zero-rated Beer and Wine.

B: This is an OFF Licence; alcohol will not be consumed on site. We call for alternative transport for our customers.

C: A non-negotiable policy requires all customers under the age of 25, that are buying restricted items to produce Identification.

D: Point of Sale software prompts operators to confirm age and locks the sale until a Supervisor releases it. Our customers services team are trained to watch out for multiple purchases by at risk customers, in addition to any attempts to purchase alcohol by intoxicated or underage customers.

E: Bottled Water is available during Wine/Beer Tastings.

F: We use a Web based training system – Redseed that requires all our customer Service Team members to undergo training and complete an online test covering the Sale of Liquor.

G: New World Halswell keeps within all known District Authority Noise Levels.

H: We have no knowledge of any deviant, antisocial and disruptive behavior resulting from the Sale of Liquor at New World Halswell.

I: New World Halswell is a well-respected business that has been selling alcohol responsibly for over 24 years.

J: This is a renewal application within an established shopping precinct and car parking area, there will no impact on land use. Our carpark is constantly monitored by CCTV. In the area is a Super Liquor Bottle store, Craythornes Tavern and The Vicarage Restaurant. Our Supermarket has significant Car Park surrounding our store. The granting of the Licence will not change the neighbouring land use.

# 12. Important to note - Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

- 1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. # **15. Processing Timelines:**

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
