Hoyts does not promote any excessive consumption, so the following are not allowed within our venues. Drinking games, drinking challenges, alcohol promotions involving travel or where an item is discounted more than 25%

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Service ticketed guests, or guests of pre-arranged functions only. Proof of age will be required from anyone who may appear to be under the age of 18. Refuse service to anyone who is intoxicated. Employees will monitor guests during before and during screenings

Water is freely available from the bar for any patron and displayed as such

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All alcohol service, whether from bars, at functions will be governed by the applicable licensing regulations, including RSA. Only staff aged 16 and older will be permitted to sell, serve or have access to alcohol. Additionally all staff are trained using internal systems for RSA

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Being a cinema the tenancy has heightened sound proofing to restrict sound bleed from each cinema to the exterior. In addition yhe cimena is located within the Westfield Shopping Centre further restricting noise to the exterior area.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

No known level of nuisance or vandalism for this location. Hoyts Riccarton cinemas are located within the Westfield Riccarton Shopping Centre and therefore has security and supervision for the immediate surrounds to minimise any nuisance or vandalism.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Some of the food vendors in the Centre are licenced (The Fox, La Porchetta) As all licensed venues in the Shopping Centre are family friendly we don't believe that renewing the license for Hoyts will increase alcohol related issues in the area.

The Premises is located within the Westfield Riccarton Shopping Centre. We don't believe that granting a renewal of licence will make an impact on the neighbouring use.
