Several water jug/glasses location on the premises and also a water station is plumbed into the bar.

Our managers are required to have training to demonstrate their understanding of the laws and compliance with them in our business.

The current noise levels are low and we use outdoor noise restrictions on our outside balcony area from 10:30pm

The premises has installed cameras to monitor and record any nuisance or vandalism incidents in our neighborhood. Our cameras on the London street have already been used to assist the police with general incidents.

There are various licensed eateries, bars and restaurants along and around London st. Our business does not add any problems within this environment.

 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
