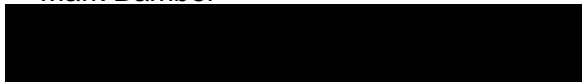

We have a full cabinet range available and a menu available at all times.

- Non-alcoholic refreshments:

We have a wide range of non alcoholic beverages available and free water promoted at all times

- Low-alcoholic beverages (Between 1.1% and 2.5%ALC):

We have low alcohol and non alcohol beers available

- Alcohol range available (attach full drinks menu)

Wines, beers, ciders and a limited range of spirits.

b. What steps does the applicant propose to take to provide assistance with or information about alternative forms of transport from the premises, for staff and patrons?

We sign post alternative travel arrangements, being a small village we encourage a walk home where this is feasible, we also encourage a sober driver and offer free soft drinks to this person. We also offer rides home to our patrons and staff when appropriate

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Substantial food is always available whilst we are serving alcohol. We provide free water and non alcoholic beverages. We encourage people to slow down or stop drinking. We do not serve minors or any other prohibited persons and we have clear signage on rights and responsibilities.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

We have clear signage as regards prohibited persons. We do not serve intoxicated people - we work with anyone who shows signs of intoxication to get them home and/or to provide water and food. We will always ask for identification and check this carefully.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

We have a water station with bottles filled with free water and glasses available.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All staff follow an induction where all aspects of Host responsibility are covered including the legal obligations of the sale and supply of alcohol. We also cover providing a safe work environment and our fire and evacuation procedures.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Current sound issues may arise from customers leaving the premises later at night or from music from the premises. We encourage customers to be respectful of our neighborhood and leave the premises quietly. We keep music levels to a suitable level.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

There are no issues in this regard. We will encourage our customers to be respectful of the local area. Many will be local people who care about the town and so are naturally likely to follow this. Encourage visitors in this too.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There is a parade of restaurants one block away. As the cinema is already an established venue there should not be any increase in issues. There are no bars or clubs or late night venues so this reduces the likelihood of issues. We monitor this ongoingly.

As a license already exists this will not be an issue.

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

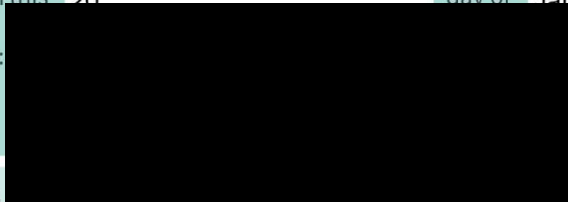
