Promoting Low Alcohol and No Alcohol options - Free water in locations around the premises

Evidence of age paramount to staff - if under 25 in appearance to produce legal I.D. Producing club card to prove you are a authorised visitor. Monitoring patrons at all times for signs of intoxication

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

We have a portable unit upstairs servicing the 2nd Floor
we have a plumbed unit downstairs servicing the downstairs area (by bar)
we have a plumbed unit servicing both greens

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

We have rostered bar staff who are trained and familiar with the laws and responsibility. For functions our Duty Manager will be on hand
Most of our bar staff have worked in the industry in the past and have extensive knowledge

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

We are fortunate that the only immediate neighbours border our southeastern boundary. Any noise from entertainment areas do not carry in that direction unless it is extensive and would be stopped anyway
we do keep windows shut particularly in the evening. we also sometimes have security for the carpark and outside spaces

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

we have very little problems in this way. we have now got surveillance cameras that can be monitored from behind the bar and a monitored alarm system

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There is a small community bar on Harris Crescent about 800m away. other than that the nearest is Bishopdale and Papanui. we have never contributed to alcohol related problems and our safety measures that are in place should ensure this continues

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

we are part of the greater Edgar McIntosh Park complex and with our intention of better utilisation of the premises as a sports hub going forward. we currently host Manof Aibion RFC and Marist Hockey. nothing will affect land use

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

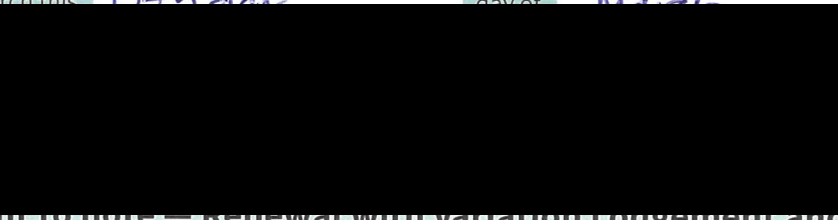
The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

14. Important to note – Renewal with variation Lodgement and Invoicing

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application. More information about statutory timelines can be found at ccc.govt.nz/alcohol
