5. No promotions involve free alcohol, drinking games, or any practice that encourages rapid drinking.
6. Discounts or special offers on alcohol are conducted in a manner that does not lead to irresponsible drinking behaviours.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

1. All staff will be trained in identifying intoxicated persons and minors.
2. The premises will operate a strict ID verification policy (e.g., requiring proof of age for those appearing under 25).
3. Any person showing signs of intoxication will not be served alcohol and will be encouraged to arrange safe transport home.
4. CCTV may be used to monitor the behavior and support responsible service practices.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Free drinking water will be available at the bar and water station on request.

Water jugs will be placed on self-service water stations.

1. Regular staff meetings will include updates on liquor licensing laws and best practices.
2. A duty manager will always be on-site to oversee responsible service practices.
3. Incident logs will be maintained to document any alcohol-related issues.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Current noise levels are within permitted limits.

Future noise levels will be managed by:

1. Ensuring music and entertainment levels comply with local council regulations.
2. Monitoring noise levels regularly and making adjustments as needed.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

The current and future levels of nuisance and vandalism are very low.

CCTV surveillance will be in place to deter anti-social behaviour.

Staff will conduct regular patrols around the premises to identify and address potential issues.

Clear signage will be displayed, reminding patrons to behave responsibly.

Waste management plans will ensure the surrounding area is kept clean.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

This application is unlikely to contribute to an increase in alcohol-related problems, as the premises will operate under strict host responsibility policies.

The venue will implement proactive measures to promote safe and responsible drinking, minimizing any negative impact.

The surrounding land is currently used for commercial.

The premises will not negatively impact neighbouring land use, as it will adhere to all council regulations and noise control measures.

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
