No Current and foreseen future noise problems relating to the sale of alcohol from the Supermarket.

There are no current problems with nuisance or vandalism in the area. However if a problem presents itself Security Personnel will be hired to deal with it.

There are only a small number of licensed restaurants and cafes and bars in close proximity. We don't believe granting this license will increase alcohol related problems in the area.

Premises is part of a shopping centre and the license renewal is unlikely to change the neighbouring land use.

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
