

## GENERAL CONDITIONS OF MOBILE OR TRAVELLING SHOP PERMIT

# CHRISTCHURCH CITY PUBLIC PLACES BYLAW 2008 TRADING AND EVENTS IN PUBLIC PLACES POLICY 2010

- 1. No mobile or travelling shop shall be stopped for the purpose of carrying on or soliciting business on the roads specified in Schedule A.
- 2. The permit holder or operator of any mobile or travelling shop shall not stand or remain stationary in any public place or road except for such time as may be reasonably required for the transaction of business with customers on that occasion, and in any case shall not remain stationary on any one site for a period exceeding one hour, nor stand on any one site more than twice in any eight hour period.

The permit holder or operator shall, when requested by any Police Officer or authorised officer of the Council, alter his position or move from place to place on any road or public place as directed.

- 3. Should the permit holder or operator fail to comply with the provisions of Condition 2 or if the mobile or travelling shop owned or operated by him or under his control is left unattended in any road or public place it shall be lawful for any officer mentioned in Condition 2 above to move the mobile or travelling shop to any safe position.
- 4. The permit will apply only to the vehicle whose registration number is specified on the permit. The use of any other vehicle will not be permitted without prior written consent from the Council.
- 5. The permit holder or operator shall operate any mobile or travelling shop used in connection with the permit, in such a manner as to avoid causing any nuisance, annoyance or danger to any person.
- 6. No mobile or travelling shop shall stand or operate within 50 metres of any intersection, or within 50 metres of any curve in the roadway where visibility could be reduced or restricted.
- 7. The mobile or travelling shop permit is valid during the daylight hours only.
- 8. The permit holder or operator shall at all times when selling under the authority of a permit, carry the permit with him/her and shall on demand show the permit to a Police Officer or authorised officer of the Council.
- 9. The permit holder or operator shall remove any litter from the surrounding area of the mobile or travelling shop which has been generated by the activities of his/her operations.
- 10. The permit holder or operator shall comply in all Acts, regulations, bylaws or ordinances applicable to the operations of the permit, including the preparation and sale of food and any vehicle used in conjunction with the activity.
- 11. The permit holder shall carry adequate, sufficient and suitable public liability insurance cover and will provide evidence of same if requested.
- 12. The permit to keep a mobile or travelling shop is not transferable to another person. If the business or vehicle is sold or transferred to another person, the Christchurch City Council must be notified within 14 days. The new owner will be required to apply for a permit and will not be permitted to use the mobile or travelling shop until a permit is issued.
- 13. The permit holder is to supply a copy of written approval from a registered craftsman gasfitter, relating to an annual inspection of all LPG equipment.
- 14. That the above conditions may be reviewed at any time and amended as necessary.
- 15. Trading is not permitted within 200 metres of an existing business selling the same or similar product.

### **EXPLANATORY NOTES**

#### Clause 2

Please read and understand, especially the time requirements as for transactions and moving on within the required period.

#### Clause 10

- 1. If food is being sold, the vehicle must have a current Food Hygiene Certificate.
- 2. To comply with the requirements of the Public Place and Signs Bylaw 2003:
  - signs no larger than 900 mm x 600 mm (one front and rear of vehicle)
  - goods not to be placed on the public place
  - sale goods to be contained in and sold from the vehicle only.
- 3. Trading is to be made from the roadside only (not the grass berm or verge).
- 4. The permit is for the vehicle (registration number listed on the issued permit) only.
