About this form

This form is to be used to request a reconsideration of the development contributions as assessed under the Christchurch City Council's <u>Development Contributions Policy</u>.

Section 199A Local Government Act 2002 allows an applicant of a resource consent, building consent or service connection which has been assessed under the Christchurch City Council Development Contributions Policy to request a reconsideration of the development contributions assessment.

Reconsiderations must be requested within **10 working days** of the date on which the person lodging the request receives notice from the Christchurch City Council of the level of development contribution required.

Council will reconsider the development applied for against the requirements of the Christchurch City Council's Development Contributions Policy as set out in the Christchurch City Long Term Plan, along with and any other relevant information (which Council is obliged to consider) set out in the circumstances surrounding the grounds above or legislation and regulations.
- 4. You will receive written notice of the outcome of the reconsideration. You will also receive written notice if your request for reconsideration cannot be made due to expiry of time limits or other insufficient grounds.
