These do not have to be filed with this return but must be available to superquiries about thereturn if required. 3. Donations can be monetary or physical goods or services supplied or a combination thereof. 4. Donations to a candidate of labour only or donations of goods and services that have a fair market value of \$300 or less do not have to be declared – see \$103A of the LEA 2001. 5. Candidates must declare donations from each contributor that exceed \$1500 in value. Where a contributor has made donations in instalments that sum to more than \$1500 in value, ear contributing donation needs to be listed in Part A and the aggregated sum shown. 6.
