| <p>PARTICULARS:</p> <p>The Council is satisfied the building at the property, is dangerous under s121(a)(i), (ii), and (b) and insanitary under s123(a)(i), (b), (c), and (d) of the Building Act 2004.</p> <p>S121 Meaning of dangerous building:</p> <p>(1) A building is dangerous for the purpose of this Act if,-</p> <ul style="list-style-type: none"> (a) In the ordinary course of events (excluding the occurrence of an earthquake), the building is likely to cause- <ul style="list-style-type: none"> (i) Injury or death (whether by collapse or otherwise) to any persons in it or to persons on other property; or (ii) Damage to other property (b) In the event of fire, injury or death to any persons in the building or to persons on other property is likely. <p>S123 Meaning of insanitary building:</p> <p>A building is insanitary for the purposes of this Act if the building-</p> <ul style="list-style-type: none"> (a) Is offensive or likely to be injurious to health because- <ul style="list-style-type: none"> (ii) It is in a state of disrepair (b) Has insufficient or defective provisions against moisture penetration so as to cause dampness in the building or in any adjoining building; or (c) Does not have a supply of potable water that is adequate for its intended use; or (d) Does not have sanitary facilities that are adequate for its intended use. | | |
