## Lichfield Street car park conditions of use

These conditions are in operation 24 hours a day, 7 days a week and apply to the driver and owner of the vehicle.

## Conditions of use

When using the Lichfield Street car park you accept the conditions below:

- You must comply with all directions issued by council staff or car park security.
- You must comply with all signs displayed in the carpark.
- You must not obstruct other persons or vehicles using the carpark.
- You must not park in any area marked 'Reserved' or 'No parking' or outside of the line-marked parking bays.
- You must not park in a mobility bay without a current mobility permit.
- The vehicle you are parking must be able at all times to be driven under its own power and not present any danger or risk to other vehicles or persons or the carpark.
- You must pay prior to leaving the carpark at one of the self-service pay stations.
- Failure to pay may result in the driver or owner of the vehicle being invoiced for a 24 hour period in addition to administration costs.
- This car park is under video surveillance and the council reserves the right to provide any video footage to the NZ Police or in the event of a motor vehicle accident claim to an insurance company.
- You must provide your full name and address if asked by us and agree that we are able to obtain the name and address of the owner of the vehicle from the motor vehicle register and to pass this information on to third parties for the purposes of debt recovery if necessary.
- If we fail to act or pursue any right or remedy available to us this will not in any way prejudice our right to exercise that or any other right or remedy.

## Responsibility for damage

- You are liable for all costs of any damage to the carpark caused by you or your vehicle.
- While the council will take all reasonable care, we cannot guarantee the security of your vehicle while left in the car park. We accept no liability for any claim by you or any other person, whether for loss or damage to your vehicle or any other vehicle, any property left in your vehicle whether resulting from using the carpark or being unable to use the carpark or for negligence or otherwise.
- We accept no liability for any loss or damage to any article left in our custody or control. Our employees are not authorised to accept any of your possessions for safe custody except the keys to your vehicle where possession is taken at our request. You agree to indemnify us in respect of any claim made against us arising from your use of the car park or the use of the carpark by anyone else with your authority.

## Interpretation

To avoid any confusion as to the meanings of these conditions:

- 'claim' includes any claim for damage, loss or compensation and any demand, remedy, liability or action.
- 'damage' includes direct, indirect, consequential and special damage
- 'debt' includes previous unpaid parking fees and/or unpaid enforcement notices.
- 'vehicle' includes its accessories and contents.
- 'we' and 'us' means the Christchurch City Council and includes any of its employees, agents and independent contractors.
- 'you' includes both the driver and the owner of a vehicle entering the carpark.
- 'your vehicle' means the vehicle which you are driving, regardless of whether it is owned by you.
- 'notice' means parking infringement notice.
