DECISION 19

Chapter 21 Specific Purpose Zones — Stage 2 (and Relevant Definitions and Associated Planning Maps)

Background

- [1] The Hearings Panel ('the Panel') issued its decision on Chapter 21 Specific Purpose Zones ('Decision 19') on 30 March 2016. We received a joint memorandum ('the memorandum') from the Christchurch City Council ('the Council') and Pegasus Health (Charitable) Limited requesting a minor correction to our Decision 19 on 8 April 2016.¹
- [2] Clause 16 of Schedule 3 to the OIC provides as follows:
 - (1) The hearings panel may, at any time, issue an amendment to a decision to correct a minor mistake or defect in a decision of the panel.

Joint memorandum of counsel between Pegasus Health (Charitable) Limited and the Christchurch City Council and Pegasus Health (Charitable) Limited seeking a minor correction to Decision 19, 8 April 2016.

(2) This power includes the power to amend or correct a proposal, provided that the amendment or correction is made before the proposal becomes operative in accordance with clause 16 of this order.

Reasons for the corrections

[3] The memorandum sets out the requested corrections in paragraph 7. In short, these apply to a street numbering and legal description error in Schedule 3 of Decision 19 in relation to changes to the zoning of the Pegasus Health 24 Hour Surgery on Colombo Street and Caledonian Road.

Decision

[4] The street numbering and legal description in Schedule 3 to Decision 19 amounts to a minor error and can be corrected using our powers under cl 16 of Schedule 3 to the OIC. Decision 19 is hereby amended in accordance with Schedule 1.
